MEMBERSHIP AGREEMENT

Membership will be subject to all Deer Creek Golf Club (DCGC) Rules and Regulations and to the following:

- 1) Member will be responsible for all charges signed for by member or member's family, or incurred by the use of member's card whether or not authorized until DCGC receives written notification the card is lost or stolen.
- 2) Member will be responsible for damage to any property of DCGC, caused by member or member's family, guests or invitees.
- 3) All goods and services are invoiced monthly and are payable upon receipt in cash or by check. Member will pay interest at 18% per year on all sums not paid within thirty (30) days after the date of invoice for such sums, plus collection, court costs, and attorney's fees incurred in collecting such sums. Charging privileges may be suspended if member's account is more than sixty (60) days delinquent.
 - a) If account remains unpaid past 120 days, membership privileges will be terminated.
- 4) Membership fees are not refundable for any reason, including pandemic, economic or other catastrophes. Membership privileges are not assignable unless approved by DCGC.
- 5) Membership privileges may be revoked by DCGC for violation of DCGC rules & regulations.
- 6) Use of the DCGC facilities is at the sole risk of the member, and member waives any claims for loss or damage to member's property in connection with member's use of the DCGC facilities.
- 7) Member agrees to hold DCGC harmless for any and all injuries incurred while on DCGC property.
- 8) Renewal of this membership is subject to prior approval of DCGC in its sole discretion.
- 9) All facilities, equipment, hours, prices, services, rules, regulations and policies of the DCGC are subject to change at the sole discretion of DCGC without notice.
- 10) Member acknowledges that membership is not an investment in the DCGC, dues or other assessments are pre-paid user fees, and do not create or convey a legal or equitable property interest of any kind, nature, or description whatsoever in either the DCGC or the DCGC facilities.
- 11) Member use is limited to the facilities at DCGC and does not extend to any other properties.
- 12) Member acknowledges that at DCGC's option, the DCGC may be closed for routine or necessary maintenance repair.
- 13) Member acknowledges that DCGC is sole owner of the DCGC and all DCGC facilities with the sole right to operate the DCGC and DCGC facilities. These rights include but are not limited to:
 - a) The right to change or discontinue operation of the facilities.

b) The right to exercise any and all other rights of ownership including the right of sale to others.

Membership in the DCGC will be governed by these terms and conditions, and the DCGC rules and regulations. Such terms, conditions and rules and regulations will be determined by DCGC in its sole discretion.

Ownership of a home in the community in which the DCGC is located confers no membership rights upon the owner, nor any right to make application for membership, nor any right to make use of the golf course or other related facilities. Fees charged for the use of the golf course and clubhouse and membership in the DCGC are subject to the sole discretion of DCGC and may change without notice. No representation is made regarding the type or availability or number of memberships that DCGC may offer from time to time.
